

Leopard cub smuggled from Bangkok rescued

THE officials of the Air Intelligence Unit (AIU), who often seize gold and currency, were in for a surprise when they checked the luggage of a passenger.

They zeroed in on Kaja Moideen (45), who had arrived from Bangkok in Thai Airways flight TG337, after they found him moving about suspiciously. The muffled cries from his luggage gave away the secret.

When questioned, Kaja Moideen was evasive in his replies and he was then brought to the Air Intelligence Unit room for questioning.

On checking his stroller bag, a pink plastic basket was found, in which there was a leopard cub.

The shocked animal was making shrill noises and appeared to be weak. The custom officials fed milk to the cub. Soon, the officials of the Wildlife Crime Control Bureau (WCCB) were called in and they confirmed it to be a leopard cub of Panthera Pardus species.

A veterinary doctor from the Aringar Anna Zoological Park was summoned to run a health check, who informed the officials that it was a female cub weighing 1.1 kg and measured 54 cm in length.

He gave the animal a clean bill of health.

The cub was seized under the provisions of Customs Act 1962 read with Wild Life Protection Act, 1972 and CITES.

The cub along with the passenger, was handed over to the Tamil Nadu Forest

Kumki coming to push Chinnathambi back into forest as scare tactics fail

THREE days of tiring trek. 140-odd kilometres covered. It is a notable record for a 25-year-old wild elephant - Chinnathambi, who has temporarily paused his 'aimless' roaming owing to extreme exhaustion on Saturday morning - to have come thus far despite Forest officials' attempts to drive him back into the reserve forest (20 km away from his current location). This cat and mouse game with the jumbo has forced the hands of officials to bring out the big guns - Kaleem, a kumki from Topslip near Pollachi to capture Chinnathambi. It came as a shock for the of-

officials to spot the elephant after taking a detour to enter a human settlement, and camping near a pond on Maivadi Road in Madathukulam block. Officials already on the terrorsheets due to Chinnathambi's excursion had to contend with a swarm of visitors out to see the jumbo visitor: Tirupur District Forest Officer PK Dileep, along with around 80 officials, was monitoring the development.

After having trekked a long distance, Chinnathambi was seen resting near the pond till 5 pm on Saturday. There was panic in the air for a brief while as the elephant did not move from the place for a long time, sources said. Udumalai Forest Range Of-

ficer C Dhanabalan, whose team was also engaged in tracking Chinnathambi's movements, told Express that the elephant had travelled nearly 140 km in the last three days. "On Saturday morning, I saw the jumbo resting near Maivadi Road. After the news of his arrival spread like a wild fire, villagers began thronging the place to get a glimpse of him. All measures have been taken to ensure that people do not get close to him," he added. Dhanabalan also informed that kumki Kaleem was on its way to help capture Chinnathambi.

While the operation was expected to be carried out on Sunday, official sources said that they were also planning to

engage another kumki Mariappan. When asked about the department's plans to relocate Chinnathambi, Chief Conservator of Forests (Coimbatore Circle) Deepak Srivastava told Express, "The Forest department and Anti-Poaching Watchers have been continuously monitoring the movement of the jumbo. Top officials have made some plans to relocate the animal. However, it cannot be revealed now."

S Ramasamy from Madathukulam, who visited Chinnathambi after he became the talk of the town, said, "Villagers were not allowed to cross the railway tracks near the pond to get a clear view of the elephant."

Two elderly couples commit suicide

TWO elderly couples committed suicide by consuming poison in two different incidents in the city in the early hours of Saturday.

In the first incident, the deceased were identified as Subramani (75) and wife Nachiyammal (68), residents of Perur on the city outskirts. In the wee hours of Saturday, Subramani had some breathing trouble. Nachiyammal gave water to him, but Sub-

ramani fainted and died. Within minutes, Nachiyammal also fainted and died on the spot.

The couple died in front of their son Karthik, who had been living with them after his wife left him. On information, the Perur police conducted inquiries and found that the couple had consumed poison.

According to the police, Karthik's was an inter-caste marriage. "His parents did not object to this. However, Karthik was a liquor addict,

due to which his wife left him. Frustrated with Karthik's lifestyle, the couple committed suicide," police said.

The Perur police sent the bodies to Coimbatore Medical College Hospital for autopsy.

In the second incident reported from Saravanampatty in the city, another elderly couple committed suicide as none of their children came forward to look after them.

The deceased were identified as Palanisamy (65) and wife Kaliyammal (55), residents of Sivanandhapuram in

Saravanampatty. The couple had three daughters and one son, all married. As Palanisamy was suffering from age-related ailments, he was not able to walk and Kaliyammal was not able to take care of herself and husband. Frustrated over this, the couple reportedly consumed poison on Friday night and was found dead on Saturday morning.

On information, the Saravanampatty police registered a case and were probing into the matter.
