Whereas, Industrial Investment Bank of India (IIBI) and IDBI ("Secured Creditors") extended various financial facilities to Ashok Paper Mills Limited ("Borrower").

Whereas, IDBI assigned the debts together with the underlying securities due to it from the Borrower in favour of Stressed Assets Stabilisation Fund ("SASF"). SASF has further assigned the debts together with the underlying securities in favour of Omkara Assets Reconstruction Pvt. Limited.

Whereas, IIBI, has assigned the debts due to it from the Borrower together with the underlying securities in favour of Kotak Mahindra Bank Limited ("KMBL").

Whereas, the Authorised Officer of KMBL (AO) had issued demand notice dated 09.09.2021 under the provisions of Section 13(2) of the SARFAESI Act and called upon the Borrower, guarantors and mortgagors to pay the amounts mentioned therein, within 60 days of receipt of the said notice. The said demands were not complied with.
