Sub: Notice for Sale of the Mortgaged Property

- 1. We refer to Demand Notice dated 16.09.2019 issued by PNB Housing Finance Limited (hereinafter referred to as "PNBHFL") under Section 13(2) of the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 (hereinafter referred to as "SARFAESI Act"), related to Loan Account No. NHL/VJWD/0217/358022 wherein PNBHFL had called upon you to pay the dues of Rs. 5,44,69,448.73/-(Rupees Five Crore Forty Four Lakh Sixty Nine Thousand Four Hundred Forty Eight and Seventy Three Paisa Only) due and payable as on 16.09.2019 along with future interest applicable from 17.09.2019 until payment in full (hereinafter referred as the "Outstanding Amount") and payable by you all under the facilities granted by PNBHFL within 60 days from the date of the said notice. You have since then failed and neglected to pay the amount as demanded.
- 2. **PNBHFL** has vide an assignment agreement dated **04.03.2023** ("Assignment Agreement") has assigned the debts due and payable by you in favour of Kotak Mahindra Bank Limited (hereinafter referred to as "KMBL/The Bank") along with all its rights, title, interests, benefits in the facilities granted by PNBHFL with other incidental right thereto including the

assignment of the said facilities along with the underlying securities. As per the said assignment agreement, KMBL has become full and absolute owner and as such is legally entitled to receive the repayment of the financial facility or any part thereof including the right to file suits, institute such other proceedings in its own name and to take such other action as may be required for the purpose of the recovery of the said financial facility. KMBL has become the absolute owner of the said account(s) and all rights, title and interest in respect of the outstanding amount pertaining to above said account(s) is now vested with The Bank.

- 3. It is pertinent to note that despite the service of the above mentioned notice, you have failed to liquidate the outstanding dues and as such the Authorized officer of PNBHFL has taken possession of the property described herein below in Annexure "A" (and referred hereinafter as "Secured Asset") on 12.12.2019 in exercise of the powers conferred on him under Section 13 (4) of the said Act read with Rules 8 & 9.
- 4. After taking possession of the secured asset, inspection was carried out by approved valuer in compliance of Rule 8(5) of the Security Interest (Enforcement) Rules, 2002 and on the basis of the report of the valuer, secured asset as mentioned in Annexure "A" was conducted on various occasions and lastly on 12.07.2021 with the Reserve Price of Rs.4,15,00,000/-(Rupees Four Crore Fifteen Lakh Only). However they all failed for want of bidders.
- 5. Hence, for recovering its legal dues, the Bank is now proposing to again invite tender/conduct auction of secured asset on the reserve price of Rs. 3,50,00,000/- (Rupees Three Crore Fifty Lakh Only) below which the said secured asset will not be sold and which sale will be on "as is where is", "as is what is basis" and "whatever there is basis".
