The CBI on Thursday arrested one of the alleged kingpins in the NEET-UG paper leak case who was on the run ever since the crackdown on irregularities in the entrance exam began, officials said.

Rockey alias Rakesh Ranjan, who hails from Nalanda, and is said to be a relative of mastermind Sanjeev Mukhia, was nabbed by the agency from outskirts of Patna, they said. The CBI had been trailing him since the case came to the agency. His run came to an end Thursday morning when he was arrested by the agency, they said.

The agency produced him before a special court in Patna which has remanded him to 10 days of CBI custody, they said. The CBI conducted

SC to hear pleas related to **NEET-UG** case on July 18

NEW DELHI: The Supreme Court on Thursday said the pleas related to the controversy-ridden medical entrance exam NEET-UG 2024 would be heard on July 18.

A bench headed by Chief Justice DY Chandrachud noted that the Centre and the National Testing Agency (NTA), which conducts the prestigious test, have filed their affidavits in compliance with the apex court's July 8 order. The bench , also comprising Justices J B Pardiwala and Manoj Misra, observed that lawyers appearing for some of the petitioners have not yet received the affidavits filed by the Centre and the NTA. It posted the matter for hearing on July 18.
