**Sub: Notice for Sale of the Mortgaged Property**

1. We refer to Demand Notice dated 23.09.2022 issued by Kotak Mahindra Bank Limited (hereinafter referred to as "**The Bank/KMBL**") under Section 13(2) of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 (**hereinafter referred to as "SARFAESI Act"**), related to Loan Account No. 455FBSGJ554657 wherein we had called upon you to pay the dues of Rs. 8,71,909/- (Rupees Eight Lakh Seventy One Thousand Nine Hundred and Nine Only) outstanding as on 23.09.2022 with further interest applicable from 24.09.2022 until payment in full (**hereinafter referred as the "Outstanding Amount"**) and payable by you under the facilities granted by **Bajaj Finance Limited (hereinafter referred to as "BFL")** within 60 days from the date of the said notice. You have since then failed and neglected to pay the amount as demanded.
2. BFL has vide an assignment agreement dated **30.03.2022 ("Assignment Agreement")** has assigned the debts due and payable by you in favour of the Bank along with all the rights, title, security interests, benefits, financial documents, in the facility(ies) granted by BFL with other incidental right thereto including the assignment of the said facility along with the underlying securities. As per the said assignment agreement, KMBL has become full and absolute owner and as such is legally entitled to receive the repayment of the financial facility or any part thereof including the right to file suits, institute such other proceedings in its own name and to take such other action as may be required for the purpose of the recovery of the said financial facility. KMBL has become the absolute owner of the said account(s) and all rights, title and interest in respect of outstanding amount pertaining to above said account(s) is now vested with Bank.
3. It is pertinent to note that despite the service of the above mentioned notice you have failed to liquidate the outstanding dues and as such the Authorized officer of KMBL has taken physical possession of the property described herein below in **Annexure "A"** (and referred hereinafter



as "**Secured Asset**") on 03.05.2024 in exercise of the powers conferred on him under Section 13 (4) of the said Act read with Rule 8 & 9 and in pursuance of order dated 06.02.2024 passed by Hon'ble District Magistrate Cum District Collector, Udaipur under section-14 of the said SARFEASI Act.

4. After taking possession of the secured asset, Inspection was carried out by Approved Valuer in compliance of Rule 8(5) of The Security Interest (Enforcement) Rule, 2002 and on the basis of the report of the valuer, the Reserve Price of the secured asset is fixed at Rs.7,50,000/- (Rupees Seven Lakh Fifty Thousand Only).
5. This is to inform you all that all the requisitions under the provisions of SARFAESI Act and The Security Interest (Enforcement) Rules, 2002 have been complied with and the Bank now proposes to sell the secured asset by public auction and/or any other methods as prescribed under the provisions of Rule 8(5) of Security Interest (Enforcement) Rules, 2002 after a period of 30 (thirty) days from the date of this notice **along with the existing encumbrances if any on 'as is where is basis & As is what is basis & whatever there is basis'**, unless the bank receives the entire outstanding amount i.e., Rs.10,81,863/- (Rupees Ten Lakh Eighty One Thousand Eight Hundred and Sixty Three Only) outstanding as on 28.06.2024 with further interest applicable from 29.06.2024 until payment in full and other charges as demanded in the said demand notice, within the statutory period of 30 (thirty) days from the date of the present notice. Please note that if in case auction scheduled herein fails for any reason whatsoever then the Bank may again enforce the security interest by putting the said secured asset on sale through public auction or private treaty as per its discretion. Please also note that you are further liable to make good the loss incurred after sale of the secured asset, if any.

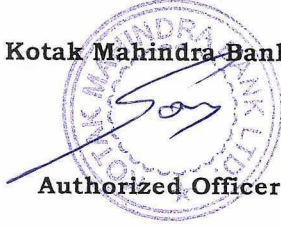
