Driver wades through...

The Judicial Magistrate rejected the bail plea of the driver after the Delhi police derisively dubbed him a "mastikhor." The court noted that the allegations against the accused Manuj Kathuria were "serious in nature" and observed that the CCTV footage showed he was "warned of the dangers ahead by some passers-by, but he did not pay any heed".

The lower court further noted that the accused can be seen driving at a high speed on an already heavily waterlogged road, causing a large displacement of water, which entered the basement and "resulted in the loss of innocent lives".

In the high court, however, the two-judge bench chose to comment on the absurdity of it all, by pointing out that the Delhi Police was taking action against an SUV driver who happened to be driving outside the IAS centre but not acting against the Municipal Corporation of Delhi (MCD) officials.

"What is the Delhi Police doing? Have they lost it? What are its officials, who are monitoring the probe, doing? This is a cover-up or what?" the court said.

"Has any official been caught or interrogated? Have they interrogated the official who has not de-silted this drain? Was the drain de-silted properly and in time?" the court asked.

The court said it was strange that no MCD official has been hauled up till now. "We don't know whether the Investigating Officer has seen the de-silting plan or the approved building construction plan. We have no idea whether he has investigated the role of MCD officials," the bench said.

Another train derails

A goods train derailed near Rangapani station in West Bengal's New Jalpaiguri Rail Division on Wednesday. The incident occurred at 11:45 am when an empty petroleum wagon left the tracks.

According to North-East Frontier Railway officials, there were no injuries or fatalities reported. Railway personnel acted swiftly to clear the tracks, and regional rail traffic continued without disruption.

This derailment is particularly alarming given recent events in the area. On 17 June, three coaches of the Sealdahbound Kanchanjunga Express derailed after colliding with a goods train near Rangapani, claiming 10 lives.

Meanwhile, reacting to the incident, West Bengal Chief Minister Mamata Banerjee said on X that "we are very concerned about what is hap-

Ajit 'gatecrashes'

CM Shinde is said to have expressed surprise and assured his deputy that he would ensure that the programme was on until Pawar and Samant reached Sahyadri. Abandoning the ongoing meeting, the duo then headed for Sahvadri, sources said.

The incident has only served to expose the cracks within the Mahayuti, said NCP sources. Only recently, there was a hot debate over credit for the 'Ladki Bahin' scheme. While Ajit Pawar, being the head of the finance department, had announced the scheme while presenting the state budget in the legislature, CM Shinde is said to have asked officials to issue the government resolution (GR) the same evening, when it should have been issued only after the mandatory approval of the state legislature. During Ajit Pawar's recent tour of Ahmednagar district when he attended three events where women were invited to discuss the scheme, the banners and hoardings specifically mentioned 'Majhi Ladki Bahin', with the words 'Mukhya Mantri' being omitted.

His rude removal from the scene surely will impact the complicated peace talks that Hamas and the Israel have been engaged in via interlocutors and third countries -- US, Egypt, and Qatar. Haniyeh has been described as a key backer of the process. The action has reduced the American President, already a lame duck, to utter irrelevance, a sentiment that found voice in the US Secretary of State voicing incomprehension over the strike, other than saving that America had no hand in it. Biden had said in June that Israel was amenable to a six week initial ceasefire with a partial Israeli military withdrawal and the release of some hostages, even as "a permanent end to hostilities" was worked out through mediators. That plan, elusive as it was, looks as though it is off the table for the foreseeable future. Relentless military action by Israel on Gaza has taken the lives of about 40,000 Palestinians, and this number looks set to mount. Meanwhile, the strategic gains, of taking out the military leaders of the Hamas or of rescuing whatever hostages that remain, looks chimerical. But it suits Benjanim Netanyahu, who faces increasingly strident protests about his handling of a war which critics have labelled as cynical and political observers note is crucial to his survival. The attack comes designed to provoke Iran at a time when a new president is taking office. The attack comes at a time when Israel has been preparing to enlarge its military engagement with Hezbollah as well. By shifting the goalposts and targeting a non military person, Netanyahu has signalled that he is going flat out in this asymmetrical war: the more Palestinians are killed, the further Netanyahu remains from his goal.

Posting a link to Thakur's speech, he wrote on 'X', "This speech by my young and energetic colleague, Shri @anuragthakur is a must hear. A perfect mix of facts and humour, it exposes the dirty politics of the INDI Alliance."

This added fuel to the fire and provoked Congress president Mallikarjun Kharge into saying that in the Parliament "one's caste is not asked for" and that Thakur made the comments "deliberately to insult".

He also said that "the Prime Minister should not support such indecent things. He should know when and what to defend. I strongly condemn such indecent things and Narendra Modi's tweet in their support."

In the Lok Sabha, Opposition MPs moved to the well holding placards and protested against Thakur's speech and PM's endorsing it. At this, Speaker Om Birla said the Business Advisory Committee had decided that no one would enter the House with placards and entreated them to take their seats. He also accused the Opposition of only wanting to disrupt the House. Parliamentary Affairs Minister Kiren Rijiju then accused the Congress and Gandhi of chanting "caste, caste and caste," day and night, and then protesting when asked about caste. He alleged that the Opposition party was trying to weaken the country and democracy through its comments against the Indian Army and by attempting to "spread violence and anarchy".

The Nagpur bench had formed a technical committee to oversee the implementation of the ban. However, the committee has taken upon itself to examine the manner in which the pollution caused by the PoP idols can be mitigated. Also, the minutes of the meeting conducted by the committee reflected that the committee had contemplated getting expert opinions on the validity of the CPCB ban. "This is ridiculous, as there can be no PoP at all," Bhattacharya added.

Celebrities are entitled to protection of the facets of their personality such as their name, images, likeness, voice, signature, etc. against unauthorized commercial exploitation by third parties, the court underlined.

"Making AI tools available that enable the conversion of any voice into that of a celebrity without his/her permission constitutes a violation of the celebrity's personality rights," the judge added. "Such tools facilitate unauthorized appropriation and manipulation of a celebrity's voice, which is a key component of their personal identity and public persona."

Justice Chagla said that such form of technological exploitation not only infringes upon the individual's right to control and protect their own likeness and voice but also "undermines their ability to prevent commercial and deceptive uses of their identity". Such platforms are emboldening internet users to create counterfeit sound recordings and videos that misuse the Plaintiff's character and identity. The UPSC has clarified that it carries out "only a preliminary scrutiny of the certificates" of candidates. "Generally, the certificate is taken as genuine, if it has been issued by the competent authority. The UPSC neither has the mandate nor the wherewithal to check the veracity of thousands of certificates submitted by the candidates every year. However, it is understood that scrutiny and verification of genuineness of certificates is carried out by the authorities mandated with the task," it added.

HC notice on plea for...

filed by three citizens and nine clay idol makers and small-scale craftsmen, contending that the actions by the respondent authorities to enforce the guidelines were "farcical measures, designed only to pay lip-service to the provisions of the guidelines".

The petitioners' advocate, Ronita Bhattacharya, submitted that despite the CPCB ban in 2020, which was to come into effect in 2021, the state is dilly-dallying over its implementation, to appease the manufacturers of PoP idols. Even the Supreme Court had categorically said that the manufacture of PoP idols and their immersion in water cannot be permitted. "Despite this, it is not being effectively implemented in Maharashtra. The ban should be made mandatory under the Water (Prevention and Control of Pollution) Act, which invites penal provisions if not followed," Bhattacharya said.

The Act requires the registration of non-PoP idol makers and a publication of the list, to make people aware of the same. However. no steps have been taken in this regard. The CPCB had recommended using eco-friendly idols made of natural clay and biodegradable materials, to mitigate harm. Hence, there was a need to publish a list of idol makers using eco-friendly material.

Bhattacharya pointed out to the court that

Meanwhile, the Hume Centre for Ecology and Wildlife Biology in Kalpetta in Wayanad said they, too, had issued warnings of possible landslides in Mundakai to the district administration, at least 16 hours before the first landslide on Tuesday.

"We have a comprehensive rainfall monitoring system in Wayanad with over 200 weather stations recording data on a daily basis. Our data indicated that Puthumala, the nearest weather station of Mundakkai, had received over 200 mm rainfall on Sunday alone. This was followed by another spell of 130 mm overnight. It is important to note that a landslide can be triggered when a hilly region receives approximately 600 mm rainfall in a day or two. The region had received an unprecedented 330 mm of rainfall in just one day. Another heavy spell would have triggered a landslide," CK Vishnudas, director of Hume Centre was quoted in the media.

"We passed on this information to the district administration immediately, but we are not sure why the authorities failed to act." he added. Since June 1, several locations in Wayanad and other regions had experienced over 3000 mm rainfall. "In a span of 50 days, these areas became highly rainfall saturated. To make things worse, these regions are extremely vulnerable to landslides. This is what happened in Wayanad," Vishnudas said.
