
Sub: Notice for Sale of the Mortgaged Property

- 1. 

- 3. It is pertinent to note that despite the service of the above mentioned notice, you have failed to liquidate the outstanding dues and as such the Authorized officer of **PNBHFL** has taken possession of the property described herein below in Annexure "A" (and referred hereinafter as "Secured Asset") on 14.11.2018 in exercise of the powers conferred on him under Section 13 (4) of the said Act read with Rules 8 & 9.

However the said auction failed for want of bidders.

Hence, for recovering its legal dues, the Bank is now proposing to again invite tender/conduct auction of secured asset on the reserve price of Rs. 16,50,000/- (Rupees Sixteen Lakh Fifty Thousand Only) below which the said secured asset will not be sold and which sale will be on "as is where is", "as is what is basis" and "whatever there is basis".
