Religare Finvest Limited (Religare) has vide an assignment agreement dated 09.10.2018 ("Assignment Agreement") has assigned the debts due and payable by you in favour of the Bank along with all its rights, title, interests, benefits in the facilities granted by Religare with other incidental right thereto including the assignment of the said facilities along with the underlying securities. 


