Sub: Notice for Sale of the Mortgaged Property

1. We refer to Demand Notice dated **05.12.2022** issued by Kotak Mahindra Bank Limited (hereinafter referred to as "**KMBL/The Bank**") under Section 13(2) of the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 (hereinafter referred to as "SARFAESI Act"), related to Loan Account No. **HM/0213/H/17/100065** wherein we had called upon you to pay the dues of **Rs.5,08,753/- (Rupees Five Lakh Eight Thousand Seven Hundred and Fifty Three Only)** due and payable as on **05.12.2022** along with future interest applicable from **06.12.2022** until payment in full (hereinafter referred as the "Outstanding Amount") and payable by you all under the facilities granted by Magma Housing Finance Limited (MHFL) (subsequently known as Poonawalla Housing Finance Limited now known as Grihum Housing Finance Limited) within 60 days from the date of the said notice. You have since then failed and neglected to pay the amount as demanded.
2. **PHFL** has vide an assignment agreement dated **31.03.2022** ("**Assignment Agreement**") has assigned the debts due and payable by you in favour of the Bank along with all its rights, title, interests, benefits in the facilities granted by **MHFL** with other incidental right thereto including the assignment of the said facilities along with the underlying securities. As per the said assignment agreement, **KMBL** has become full and absolute owner and as such is

legally entitled to receive the repayment of the financial facility or any part thereof including the right to file suits, institute such other proceedings in its own name and to take such other action as may be required for the purpose of the recovery of the said financial facility. KMBL has become the absolute owner of the said account(s) and all rights, title and interest in respect of the outstanding amount pertaining to above said account(s) is now vested with The Bank.

- It is pertinent to note that despite the service of the above mentioned notice, you have failed to liquidate the outstanding dues and as such the Authorized officer of the KMBL has taken possession of the property described herein below in Annexure "A" (and referred hereinafter as "Secured Asset") on 07.06.2023 in exercise of the powers conferred on him under Section 13 (4) of the said Act read with Rules 8 & 9.

- Hence, for recovering its legal dues, the Bank is now proposing to again invite tender/conduct auction of secured asset on the reserve price of Rs.4,00,000/- (Rupees Four Lakh Only) below which the said secured asset will not be sold and which sale will be **on "as is where is", "as is what is basis" and "whatever there is basis"**.
