

Property dealer shot dead NEW DELHI: A 23-year-old property dealer was shot dead allegedly over a financial dispute in south east Delhi's Jaitpur area, police said on Saturday.

The incident happened at Mirza Associates at around 7 pm on Friday when an argument broke out between Zaid and Mohammad Firoz over a monetary issue, they said. Residents informed the police that they heard a gunshot from inside Firoz's office, a senior police officer said. According to police, the argument between the two escalated and Firoz shot Zaid dead. When the police team entered the shop they found Zaid lying in a pool of blood with a gunshot injury in his chest.
