Whereas, ICICI Bank Ltd. has assigned the debt due to it from Paschim Petrochem Ltd. ("Borrower") along with the underlying securities in favour of Kotak Mahindra Bank Limited ("KMBL").

Whereas, the Authorised Officer (AO) of Kotak Mahindra Bank Ltd had issued notice dated 29-8-2008 under the provisions of Section 13(2) of the SARFAESI Act and called upon the Borrower and the guarantors to pay the amounts mentioned therein, within 60 days of receipt of the said notice.
