

Sub: Notice for Sale of the Mortgaged Property

- 1. We refer to Demand Notice dated 11.09.2023 issued by Kotak Mahindra Bank Limited (hereinafter referred to as "The Bank/KMBL") under Section 13(2) of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security (hereinafter referred to as "SARFAESI Act"), related to Loan Account No. 606107210271687 wherein we had called upon you to pay the dues (Rupees Thirty Two Lakh Fifty Eight Thousand Three Hundred and outstanding as on 11.09.2023 with further interest applicable from payment in full (hereinafter referred as the "Outstanding Amount") and payable by you under the facilities granted by Fullerton India Home Finance (hereinafter referred to as "FIHFCL") within 60 days from the date of the said notice. You have since then failed and neglected to pay the amount as demanded.

FIHFCL has vide an assignment agreement dated **28.03.2023** ("Assignment Agreement") has assigned the debts due and payable by you in favour of the Bank along with all the rights, title, security interests, benefits, financial documents, in the facility(ies) granted by FIHFCL with other incidental right thereto including the assignment of the said facility along with the underlying securities. As per the said assignment agreement, KMBL has become full and absolute owner and as such is legally






entitled to receive the repayment of the financial facility or any part thereof including the right to file suits, institute such other proceedings in its own name and to take such other action as may be required for the purpose of the recovery of the said financial facility. KMBL has become the absolute owner of the said account(s) and all rights, title and interest in respect of outstanding amount pertaining to above said account(s) is now

It is pertinent to note that despite the service of the above mentioned notice you have failed to liquidate the outstanding dues and as such the Authorized officer of the Bank has taken possession of the property described herein below in Annexure "A" (and referred hereinafter as "Secured Asset") on 08.04.2024 in exercise of the powers conferred on him under Section 13(4) of the said Act read with Rule 8 & 9.
