# AI used to plot Tesla cybertruck blast in Las Vegas, outside Donald Trump's hotel

## WASHINGTON

The highly decorated soldier who exploded a Tesla cybertruck outside the Trump hotel in Las Vegas used generative AI, including ChatGPT, to help plan the attack, Las Vegas police said Tuesday. Nearly a week after 37-year-old Matthew Livelsberger fatally shot himself, officials said according to writings, he didn't intend to kill anyone else.

An investigation of Livelsberger's searches through ChatGPT indicate he was looking for information on explosive targets, the speed at which certain rounds of ammunition would travel and whether fireworks were legal in Arizona. Kevin McMahill, sheriff of the Las Vegas Metropolitan Police Department, called the use of generative AI a "gamechanger" and said the department was sharing information with other law enforcement agencies.

"This is the first incident that I'm aware of on US soil where ChatGPT is used to help an individual build a particular device," he said. "It's a concerning moment." In an emailed statement, OpenAI said it was committed to seeing its tools used



"responsibly" and that they're designed to refuse harmful instructions. "In this case, ChatGPT responded with information already publicly available on the internet and provided warnings against harmful or illegal activities. We're working with law enforcement to support their investigation," the emailed statement said. Launched in 2022, ChatGPT is part of a broader set of technologies developed by the San Francisco-based startup OpenAI. Unlike previous iterations of so-called "large language models," the ChatGPT tool is available for free to anyone with an internet connection and designed to be more user-friendly.

Talks between the Pakistani government and opposition parties, particularly Pakistan Tehreek-e-Insaf (PTI) party, have hit a roadblock, with allegations of government interference and restrictions on the party's access to its jailed leader, Imran Khan, Dawn reported.

Aleema Khan, Imran's sister, recently revealed that the former Prime Minister was offered a deal to move from Rawalpindi's Adiala Jail to house arrest at his Banigala residence.

In a statement on Tuesday, Aleema Khan claimed that several offers had been relaved to her brother via Khyber Pakhtunkhwa Chief Minister Ali Amin Gandapur. These offers, she said, came with the suggestion that Imran Khan remain silent, possibly in exchange for house arrest. However, she questioned how

could her brother accept such a deal after spending so long in jail. Last week, both the government and PTI denied any official offer of transferring Imran Khan to Banigala or any other location. Aleema's claims have added to the already tense situation surrounding the negotiations.

Pakistan's critical trade route with China remained blocked for the fifth day on Tuesday as thousands of people continued their protests over chronic and prolonged power outages in the mountainous region of Pakistan-Occupied Gilgit-Baltistan, media reported.

The organisers of the sit-in demonstration in Hunza, a picturesque city with a population of more than 70,000 in Gilgit Baltistan, have vowed to continue protesting until their demands are met. Rally leaders emphasised the town's persistent inadequate power supply. noting that residents endure up to 23-hour electricity outages amid a harsh winter season. Both men and women participated in the protest, braving average daytime temperatures of -4 degrees Celsius and nighttime temperatures of -10 degrees Celsius, as reported by rally participants to a media outlet via phone.
