- 1. We refer to Demand Notice dated 12.12.2022 issued by Kotak Mahindra Bank Limited (hereinafter referred to as "The Bank/KMBL") under Section 13(2) of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 (hereinafter referred to as "SARFAESI Act"), related to Loan Account No. HL/0210/H/14/100107 wherein we had called upon you to pay the dues of Rs.16,87,338/- (Rupees Sixteen Lakh Eighty Seven Thousand Three Hundred and Thirty Eight Only) outstanding as on 12.12.2020 with further interest applicable from 13.12.2020 until payment in full (hereinafter referred as the "Outstanding Amount") and payable by you under the facilities granted by Magma Housing Finance Limited (subsequently known as Poonawalla Housing Finance Limited (hereinafter referred to as "PHFL") now known as Grihum Housing Finance Limited) within 60 days from the date of the said notice. PHFL has vide an assignment agreement dated 23.03.2022 ("Assignment Agreement") has assigned the debts due and payable by you in favour of the Bank along with all the rights, title, security interests, benefits, financial documents, in the facility(ies) granted by PHFL with other incidental right thereto including the assignment of the said facility along with the underlying securities. As per the said assignment agreement, KMBL has become full and absolute owner and as such is legally entitled to receive the repayment of the financial facility or any part thereof including the right to file suits, institute such other proceedings in its own name and to take such other action as may be required for the purpose of the recovery of the said financial facility. KMBL has become the absolute owner of the said account(s) and all
