We refer to Demand Notice dated **11.06.2021** issued by Fullerton India Home Finance Company Limited (hereinafter referred to as "FIHFCL") under Section 13(2) of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 (**hereinafter referred to as "SARFAESI Act"**), related to Loan Account No.603407510234251 wherein FIHFCL had called upon you to pay the dues of Rs. 47,31,203.82/- (Rupees Forty Seven Lakh Thirty One Thousand Two Hundred Three and Eighty Two Paise Only) outstanding as on 06.06.2021 with further interest applicable from 07.06.2021 until payment in full (**hereinafter referred as the "Outstanding Amount"**) and payable by you under the facilities granted by FIHFCL within 60 days from the date of the said notice.
