We refer to Demand Notice dated **31.08.2022** issued by Kotak Mahindra Bank Limited (hereinafter referred to as "**The Bank/KMBL**") under Section 13(2) of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 (hereinafter referred to as "**SARFAESI Act**"), related to Loan Account No. 4B8BLS89144227 wherein we had called upon you to pay the dues of **Rs.19,19,290/- (Rupees Nineteen Lakh Nineteen Thousand Two Hundred and Ninety Only)** outstanding as on **31.08.2022** with further interest applicable from **01.09.2022** until payment in full (hereinafter referred as the "**Outstanding Amount**") and payable by you under the facilities granted by Bajaj Finance Limited (hereinafter referred to as "**BFL**") within 60 days from the date of the said notice. You have since then failed and neglected to pay the amount as demanded.

BFL has vide an assignment agreement dated **30.03.2022** ("**Assignment Agreement**") has assigned the debts due and payable by you in favour of the Bank along with all the rights, title, security interests, benefits, financial documents, in the facility(ies) granted by BFL with other incidental right thereto including the assignment of the said facility along with the underlying securities. As per the said assignment agreement, KMBL has become full and absolute owner and as such is legally entitled to receive the repayment of the financial facility or any part thereof including the right to file suits, institute such other proceedings in its own name and to take such other action as may be required for the purpose of the recovery of the said financial facility. KMBL has become the absolute owner of the said account(s) and all rights, title and interest in respect of outstanding amount pertaining to above said account(s) is now vested with Bank.
3. It is pertinent to note that despite the service of the above mentioned notice you have failed to liquidate the outstanding dues and as such the Authorized officer of the Bank has taken
