



FREQUENTLY ASKED QUESTIONS.

- **Effective when, would my spend based lounge access facility on Kotak Bank Debit Card be applicable from?**

The spend based lounge facility on your Kotak Bank Debit Card will be applicable from 5th April, 2024. (Not applicable to Privy Black Debit Card holders)

- **What is the new spend criteria for availing complimentary lounge facility?**

You will get complimentary lounge access in a calendar quarter only if you have spent a minimum of Rs. 5000 or more in the previous calendar quarter on your Kotak Bank Debit Card.

Example: If you spend a minimum of Rs 5000 from October 2024 – December 2024, you can enjoy complimentary airport lounge access from January 2025 to March 2025 and so on.

Note:

1. Number of complimentary lounge access in a quarter will be applicable as per your Debit Card offerings.
2. We update spends data by the 5th of the first month of each new quarter.

How It Works:

- **Early Quarter Access***: From the 1st to the 5th, we check your spends dated two quarters ago. After the 5th, your spends as of previous calendar quarter will be considered.

Example:

- **For April'25 1st-5th**: We look at what you spent from last October to December 2024.
- **After April 5th** : Your spends from January to March 2025 count for lounge access.

*Same applies for all the upcoming calendar quarters

Can I check my eligibility for complimentary lounge access prior to my scheduled date of travel?

Yes, you can check your eligibility for complimentary lounge access on Kotak Bank debit cards by visiting the following link (**please note that you will be re-directed to a third-party vendor to access your lounge details**)

- **If I have made a cash withdrawal of Rs 5000 from an ATM will it be counted for a complimentary access?**
ATM withdrawals will not be counted as a spend. Only purchases made in-store or online using your Kotak Bank Debit Card will be considered as a valid spend.
- **Do I need to spend Rs 5000 in a single transaction to be eligible for a complimentary access?**
You can spend Rs 5000 or more in a single transaction or make multiple transactions aggregating to Rs 5000 or more, in store or online. Both the scenarios will be eligible.
- **I've just opened an account with Kotak Bank and received my Debit Card, will I be eligible for complimentary lounge benefit?**

For newly onboarded customers, the feature will be available without any condition for the first calendar quarter of account opening.

Example: if you've opened your new account on 10th December 2024, you are eligible for complimentary lounge access till 31st Dec 2024. However, for the upcoming calendar quarter (Jan - Mar 2025) your complimentary lounge benefit will only be valid if you've spent Rs. 5000 or more from 10th Dec to 31st Dec 2024.

- **If I have made a Gpay/Phonepe/Paytm or any other mobile wallet-based payments will that be considered for meeting the minimum spends criteria of Rs 5000 for availing the complimentary lounge feature.**

No, the form factor for making the payments has to be debit card i.e. only POS/PG (E-com)/SI are the 3 types of transactions which are used for calculating spends by the customer in a cumulative quarter. The account-based or wallet-based transactions such as Gpay, Phonepe, Paytm etc. are not debit card payments.

- **I have made credit card bill payment /debit card EMI payments from my debit card ,will that be counted for meeting the spends criteria of Rs 5000.**

Credit card bills and DC EMI are not an eligible criteria for meeting the spends value of Rs 5000 in a cumulative quarter.

- **Will there be any additional fees charged on lounge entry?**

The lounge visit will be possible post transaction authentication with Rs. 2 from VISA debit cards. Rs 2 deducted is just an authentication fee. This is to verify that customer matches the eligibility criteria by the network. Note that the Rs 2 deducted towards swiping the card is not reversed/refunded by Visa.

- **Which lounges can I avail with my Kotak Bank Debit Card?**

You can avail entry at the following lounges using your Kotak Bank Debit Card, please note that the below list is subject to changes as per availability.

General Information:

- The access to the lounge will be available on a first come first serve basis.
- Participating Lounges may reserve the right to enforce a maximum stay policy (usually 2 or 3 hours). This is at the discretion of the individual lounge operator who may impose a charge for extended stays
- Each lounge follows its food offerings and child policy, please check with the lounge before entry
- The provision of free alcoholic drinks (wherever local law permits) is at the discretion of each participating lounge operator and in some cases may be limited. Eligible customer should make prior inquiries before ordering any separate alcoholic drinks apart from general free flow offered and will be responsible for paying any charges for additional consumption direct to the participating lounge
- Lounge staff has the right to terminate the lounge visit early or to refuse entry to any customer who is intoxicated or behaving in a disorderly fashion or is otherwise in violation of the lounge conditions and for any statutory, regulatory, or airport policy reasons including but not limited to health and safety policies or fire safety regulations
