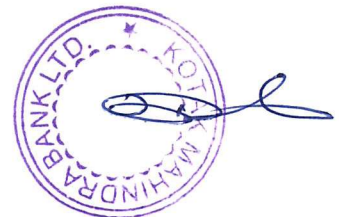
Sub: Notice for Sale of the Mortgaged Property

We refer to Demand Notice dated **09.10.2018** issued by PNB Housing Finance Limited (hereinafter referred to as "PNBHFL") under Section 13(2) of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 (hereinafter referred to as "SARFAESI Act"), related to Loan Account No. HOU/CHE/0317/369778 wherein PNBHFL had called upon you to pay the dues of Rs. 30,49,213,.89/-(Rupees Thirty Lakh Forty Nine Thousand two hundred thirteen and eighty-nine Paise Only) due and payable as on **09.10.2018** along with future interest applicable from **10.10.2018** until payment in full (hereinafter referred as the "Outstanding Amount") and payable by you all under the facilities granted by PNBHFL within 60 days from the date of the said Notice. KMBL has been subrogated in place of PNBHFL and all right, title and interest of PNBHFL in respect of Outstanding Amount is now vested with The Bank.

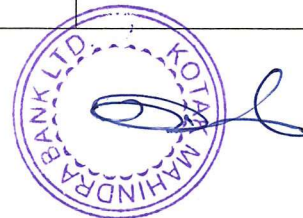

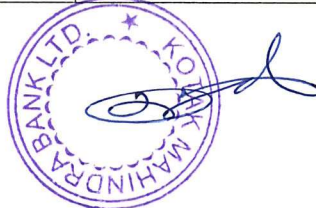
