CH Bank that, they are opposing the very same concession which was granted to the other CDs, therefor it is necessary in the interest of justice, the sale proclamation dated 15.02.2024 is requires to be cancelled/Recall.

Advocate for Certificate Holder Bank has filed say at Exh.244 and vehemently opposing the IA and prayed for rejection of IA.

Advocate for Certificate Holder Bank further requested to dispose of the IA finally and say filed by CH may be treated as a written argument also.

Advocate for Certificate Debtor No.2B has requested for granting stay on auction of properties at Sr. 2&3 and sought adjournment for filing rejoinder and argument.

In view of the facts and records, it is observed that the Certificate Holder Bank have settled the dues with other Certificate Debtors and release the properties against the deposit of OTS amount. In this matter Certificate Debtor No.2B is ready to deposit the amount as per Reserve Price as drawn by this Forum in the e-auction notice in respect of the properties at Sr. No.2 and 3 and for showing bonafide he has filed photocopies of Demand Drafts for Rs.18,03,000/- and Rs.12,15,000/- with the IA.

In view of the facts objection Application at Exh245 filed by Certificate Debtor No.2B deserves to be allowed. Hence, I passed the following direction.

#### Direction:

- 1. Interim Application Exh. No.245 is allowed.
- 2. The e-auction sale which is scheduled on 21<sup>st</sup> March, 2024 to the extent of Lot No. 2 & 3 stands stayed till further order.
- 3. Certificate Holder Bank is directed to inform the same to e-auction agency to remove the properties Lot No. 2 & 3 as per e-auction sale notice dated 12<sup>th</sup> February, 2024 from the e-auction platform immediately.
